Antony Parish Council

Minutes of meeting of the Antony Parish Council (PC) held on Tuesday 25th July 2023 at Wilcove Community hall at 7.00 pm.

- **40.23 Those present :** Cllr Coward, Cllr Bulmer (Chair) , Cllr Knott, Cllr Lobb, Cllr Murray the Clerk for Antony Parish Council, County Cllr Ewert. Visitors included Mayor Davis and Cllr Goodwin (on behalf of Torpoint Town council).
- **41.23** Apologies for absence. None.
- **42.23 Declarations of interest relating to items on the agenda.** Cllr Knott, Cllr Bulmer and Cllr Lobb declared an interest in item **43.23** Parish Cllr vacancy.
- **43.23 Co-option of Parish Councillor**. Two applications have been received. Members agreed that Cllrs Coward and Murray should interview both candidates prior to the Sept meeting. The full PC will ratify that decision at the next meeting.
- **44.23 County Councillor report** was reviewed by members and accepted by the full Parish Council.

Additional items:

- Yellow rattle is being planted by Cornwall council where verges are deemed to be a potential safety hazard. Millbrook PC are piloting this scheme.
- Cornwall Council will have a new waste management provider from April 2024.
- Once the 30mph scheme for Wilcove is implemented, hopefully it can be incorporated in the 20 is plenty scheme rollout for Torpoint in 2024.
- Cllr Ewert to contact HMS Raleigh to ask if they can provide manpower to help Tamar Community trust and the Wacker quay project.

45.23 Public forum.

Representatives from Torpoint town council informed the PC members of a plan to obtain funding for a 9 m square all weather football pitch for Torpoint. Torpoint Town Council will need support from the local community and Parish councils to secure funding.

The full PC agreed to write a letter of support for this scheme in due course, when contacted by Torpoint town council.

This will negate the need for this scheme and MOD approval. Budget allocation of \pounds 2,000 is now not needed and will be transferred to general reserves.
