Cllrs Bulmer and Lobb declared that they had an interest in the Antony village hall and notably the potential grant towards a defibrillator. Clr Coward is churchwarden at Antony. - Work at the Millbrook Skate park is starting now.
- Cllr Ewert is following up the empty flat at Hollong park.

Cllrs also discussed an unpleasant environmental sewage leak near Beach road in Wilcove. It is possible that it may be coming from Social housing septic tanks. It has been reported to the Environment agency to no avail. **Action**: Cllr R Knott to inform Clerk of specific details which can be forwarded to Cllr Ewert.
